1. School Fruit Scheme

Objectives

- **Sustainable agriculture markets**

Innovative products, stable outlets

- **Improve Public Health**

Healthy eating habits of children, access for all

- **Bringing the EU closer to its citizens**

Know-how exchange, awareness raising



1. School Fruit Scheme

Time table

- Council request June 2007
- Public consultation Dec to Feb 2008
- 122 contributions
- Impact Assessment report finalised in April 2008
- Legislative proposal 8 July 2008



1. School Fruit Scheme

Commission proposal

- MS participation is optional
- Educational and health aspects remain MS competence
- Implementing rules flexible enough to allow for all MS models to continue
- Eligibility rules allow for all education systems and policy objectives to be pursued
- Ensuring effectiveness in medium and long term



1. School Fruit Scheme

Commission proposal

- Purchase and distribution of fruit & vegetables in schools to all children between 6 - 10 years old
- Accompanying measures for information on health benefits, involvement of teachers and parents, re-establish link to agriculture
- Monitoring & evaluation and information as integrated part of any Member SFS



1. School Fruit Scheme

Member States have to:

- Draw up a prior ‘Strategy’ for the implementation
- Provide for accompanying measures to make the scheme effective
- Provide for information and evaluation measures within the scheme

Member States may:

- In addition to EC aid grant national aid also to extend age group or increase distribution frequency

Member States may not:

- Replace current funding for any existing costs by EU funding

Budget

Max. EU contribution of 90 Mio pa

National enveloppes on basis of children in core group of 6 to 10 year olds

Regional schemes possible (NUTS I level)

Reallocation of unclaimed funds in discussion

Timetable

Proposal 8 July

Council 29/30 September

Enter into force January 2009

Schemes start at beginning school year 2009/2010

September to November 2008**

Feasibility study ‘Platform’


Data scope: pip fruit, stone fruit, citrus fruit,
soft fruit, tomatoes, kiwis, asparagus

Data depth: production, forecast, stocks,
prices, varieties, consumption

General issue: Privacy, competition rules,
technical implementation

2. Market Observatory

Import Licenses

- **Availability:** TAXUD System operational in all Member states, continuous data reporting
- **Access:** AGRI direct and permanent access to data
- **Reliability:** Parallel data reporting to licenses system for confirmation



3. Standards

Two principles

Total number of specific standards has been reduced from 36 to 10 following the simplification exercise.

Ten specific marketing standards identical to the international standards set at UNECE level

3. Standards

Definition of "sound, fair and of marketable quality" corresponding to a general marketing standards for all fresh fruit and vegetables,

including the specification that full name of the country of origin must be labelled for all fresh fruit and vegetables.

The framework is the reform of the fruit and vegetable sector (see article 113a of Council Regulation 1234/2007).



3. Standards

List of the 10 specific marketing standards covering the most traded products (citrus, tomatoes, apples, table grapes, sweet peppers, peaches and nectarines, pears, lettuces, kiwis and strawberries).

This covers 75% of all trade in fresh F&V

According to data on value of trade, pears replaced cucumber in the final list

Time table

Decision process in Single Management Committee

If no majority against COM proposal – enter into force
by begin September

If majority of votes against COM proposal – Council
decision and enter into force end October

Notification to WTO on-going



4. MRL

Issue at stake:

Implementation of Reg. (EC) No 396/2005 Maximum Residues Levels of pesticides

State of play concerning the review programme of Directive 91/414/EEC

Simplification:

500.000 National MRL -> 65.000 EU-harmonized MRLs (Annex III - Part A)

Any pesticide not covered in an annex -> default MRL 0,01 mg/kg

Five directives -> one regulation

7th framework Program

- Multi-annual initiative with several priorities
- Cooperation-collaborative research
- Priority 2: Food, Agriculture and Biotechnologies / sustainable production
- 2.1.4 Socio-economic research and support to policies
- Budget 200 – 300 Mio € pa



Four key principles

- Demonstrate EU added value beyond Member states activities
- Cross-sector approach combining input from sectors other than agriculture
- Immediate support to EU policy design and implementation
- Contribute to improve competitiveness and sustainability of sector
